Our elected negotiating team has laid out a bold vision for the future of PeaceHealth. A future where every unit and department is safely staffed. A future where hospital workers have the best healthcare in our community. A future where we can recruit and retain because our wages are competitive and keep up with the soaring cost of living in Whatcom County. After sharing our bold vision with hospital administration, progress was slow in backto-back negotiation dates, but we made progress on a number of our priorities. In advance of our July bargaining dates where we expect to get administration's response to our full set of proposals — we are taking action and calling on administration to meet the moment we are in!

"The first day of negotiations this week was disappointing management rejected a lot of our proposals. The next day was a day where we saw some movement. We won language on bereavement leave that guarantees us 4 days of bereavement — up to 36 hours regularly scheduled, if we request it, so we can grieve our loved one's loss. This is a big win because we've been denied this in EVS because of short staffing." - Angie Simonds, Equipment Management



"I'm very excited to share that we got administration to change their mind about bereavement pay. They first denied it to us but later changed their minds after we shared our thoughts on how important it is for us to know that we have a guarantee that we'll be able to take time off to grieve if family members pass." **-Jose Reta, MRI**
